- 1 DO NOT VIOLATE ANY FEDERAL, STATE OR LOCAL LAW.
- 2 AVOID INJURIOUS OR VICIOUS HABITS.
- 3 AVOID PERSONS OR PLACES OF DISREPUTABLE OR HARMFUL CONDUCT OR CHARACTER.
- 4 NO ILLICIT DRUG USE OR ALCOHOL USE.
- 5 REPORT TO THE PROBATION OFFICER AS DIRECTED.
- 6 WORK FAITHFULLY AT SUITABLE EMPLOYMENT AS MUCH AS POSSIBLE.
- 7 REMAIN WITHIN A SPECIFIED PLACE, TO-WIT: THE STATE OF ALABAMA.
- 8 SUPPORT YOUR DEPENDENTS TO THE BEST OF YOUR ABILITY.
- 9 DO NOT CHANGE RESIDENCE OR EMPLOYMENT WITHOUT FIRST NOTIFYING P.O.
- 10 SUBMIT TO SUBSTANCE ABUSE TEST WHEN ORDERED TO DO SO BY THE P.O.

PROBATIONER WILL PAY ANY AND ALL COSTS OF TESTS. URINE TESTS ARE \$30.00. HAIR TESTS ARE \$80.00.

- 11 PAY THE PROBATION OFFICER \$35.00 ADMINISTRATIVE FEE PER MONTH DURING THE PROBATION PERIOD, PURSUANT TO LOCAL ACT 04-544.
- 12 THE DEFENDANT IS ORDERED TO PAY ALL FINES, COSTS, RESTITUTION, ASSESSMENTS, AND OTHER COURT ORDERED MONIES PRIOR TO RELEASE OF SUPERVISED PROBATION.

IF YOU HAVE LOST YOUR SCHEDULE OR YOU HAVE QUESTIONS REGARDING YOUR CASE (INCLUDING PAYMENTS), YOU ARE REQUIRED TO COME TO THE OFFICE AND OBTAIN THIS INFORMATION OR GO TO WWW.CO.MORGAN.AL.US (COUNTY DEPARTMENT-COMMUNITY CORRECTIONS).

PLEASE DO NOT BRING FRIENDS OR RELATIVES (INCLUDING CHILDREN) WITH YOU WHEN YOU REPORT. IF THIS IS AN ISSUE, DISCUSS OPTIONS WITH YOUR OFFICER.

OBLIGATION FOR PAYMENT OF COURT COST, FINES & FEES

- 1 ALL FEES ARE TO BE PAID MONTHLY DURING YOUR SCHEDULED REPORT-IN. PAYMENTS CAN BE MADE BY CASH, CASHIER CHECK, MONEY ORDER, AND/OR CREDIT CARD. YOU ALSO MAY GO ONLINE AT WWW.GOVPAYNOW.COM AND MAKE A PAYMENT. PLEASE BE AWARE A FEE IS ASSOCIATED WITH PAYING ONLINE. THIS IS FROM GOVPAY NOT COMMUNITY CORRECTIONS.
- 2 WHEN PAYING WITH CASH, YOU MUST HAVE CORRECT CHANGE. CHANGE WILL NOT BE PROVIDED.
- 3 IT IS YOUR RESPONSIBILITY TO PAY COURT COST, FINES, AND FEES PROMPTLY AS REQUIRED. IF YOU ARE 60 DAYS BEHIND IN PAYMENTS, WE MUST NOTIFY THE COURT OF NON-PAYMENT.
- 4 ALL COURT ORDERED MONIES MUST BE PAID IN FULL PRIOR TO YOUR PROBATION EXPIRATION
