4. I agree the Morgan County Park and Recreation Dept. has the authority to cancel this contract at any time if the fields are needed for county functions.
5. I agree the Morgan County Park and Recreation Dept. has the authority to cancel any games scheduled at any time due to inclement weather or adverse conditions of the ballfields.
6. No alcoholic beverages or unlawful activities will be tolerated at the parks.
7. Morgan County Park and Recreation will be responsible for field maintenance
